

Dear Parents/Carers,

Year 4 Redridge Residential Trip – 23rd to 27th March 2026

We are excited to offer your child the opportunity to take part in a fantastic five-day, four-night residential trip to the Redridge Centre in Mid Wales. This adventure-based trip includes on-site accommodation and a range of exciting, age-appropriate activities such as:

- Rock Climbing
- Caving
- Canoeing & Kayaking
- Mountain Biking
- And more!

Trip Details:

- Cost: £350 per child (includes travel, accommodation, meals, activities, excursions, and insurance).
- Dates: Monday 23rd – Friday 27th March 2026
- Accommodation: On-site, full-board.

Eligibility Criteria:

To attend, your child must:

- Maintain at least 96% attendance (including at the time of the trip).
- Demonstrate excellent behaviour from now until the trip.

Behaviour Policy:

- A maximum of 2 written warnings will be given for poor behaviour.
- Serious incidents (e.g. suspensions or exclusions) will result in immediate removal from the trip.

Payment Schedule:

- To secure your child's place, a non-refundable deposit of £75 is required by Thursday 31st July 2025 via ParentPay.
- Following the deposit, the remaining balance can be paid in instalments on ParentPay as outlined below:

Sunday 30 th November 2025	£50.00
Saturday 31 st January 2026	£25.00
Saturday 28 th February 2026	£50.00

You are welcome to pay more than the monthly minimum, but all payments must be received in full by 31st January 2026. Please note: missed payments may result in your child's place being offered to another pupil.

Cancellations:

- Please be aware that the £75 deposit is non-refundable, even if your child withdraws or changes their mind.
- Any cancellations that follow after the deposit will incur charges that match the payment schedule as requested by the provider.
